Subject: Safety Recall 10KWF – TRW Steering Shaft Weld

Dear Kenworth Customer,

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Kenworth Truck Company has decided that a defect which relates to motor vehicle safety exists in certain trucks with TRW steering shafts manufactured at Kenworth's Chillicothe and Renton plants between May 14, 2007 and April 20, 2009. Your vehicle has been identified as having been manufactured within this time period and may contain a defect.

The weld around the steering shaft tube that welds the splined tube to the non-splined tube may be mislocated (i.e. not fully over the seam joining the tubes together). Mislocation of this weld may allow the splined tube and non-splined tube to rotate relative to one another during a low speed, high torque turn, vehicle maneuver, possibly resulting in loss of steering control and increasing the risk of a crash. This condition was determined by Kenworth to be a safety-related defect.

<i>The problem is...</i>	Mislocated weld on the steering shaft tube
<i>What your dealer will do...</i>	Inspect and replace steering shafts that have defective welds
<i>What you must do ...</i>	Contact your dealer immediately to schedule an appointment

Kenworth has initiated a recall to inspect and replace steering shafts that have defective welds. Please contact your Kenworth dealer immediately to schedule an appointment for this repair. To find your nearest Kenworth dealer, please visit Dealer Locator at www.Kenworth.com. This repair should take no more than 1 hour, and will be performed at no charge to you. If you had this repair performed before you received this letter, you may be eligible to receive reimbursement for the cost of obtaining a pre-notification remedy of the problem associated with this recall.
