## SAFETY RECALL G-10515

OCTOBER 2010

Dear INTERNATIONAL® Customer,

This notice is being sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Navistar has decided that a defect which relates to motor vehicle safety exists in certain wheels on LoneStar model trucks built 6/11/08 thru 6/14/10 with feature code 27DRS or 27DRT.

### **REASON FOR THIS RECALL**

The front wheels on your vehicle may develop cracks at the spoke.

### **RISK TO MOTOR VEHICLE SAFETY**

A crack in the wheel may increase the risk that the wheel will separate from the vehicle possibly causing a crash potentially resulting in property damage, personal injury, or death.

### **DEFECT REMEDY**

The repair will involve replacement of all the wheels on your vehicle. Dealers have parts and instructions to repair your vehicle. The repair will be performed free of charge and take approximately 3 hours to complete. You will also be reimbursed the cost difference between the stylized wheels being replaced and those being installed.

### **ACTIONS YOU SHOULD TAKE**

Navistar's records indicate that you own a vehicle involved in this recall. The vehicle is identified on the enclosed card.

**If you own this vehicle**, please schedule an appointment with any INTERNATIONAL® dealer to have your vehicle repaired. You can find your nearest dealer by calling 1-800-448-7825 or by using the dealer locator at <http://www.internationaltrucks.com>.

**If you have already paid for repairs that corrected the defect**, you may be eligible for reimbursement of certain repair expenses if they occurred 9/10/09 thru 10/31/10. Present your original repair paperwork and proof of payment to any INTERNATIONAL® dealer and your eligibility will be reviewed. You may also submit a claim using the enclosed Request for Reimbursement card.

**If you are the lessor of this vehicle**, please forward a copy of this notice to the lessee within ten days to comply with federal regulations.

**If you do not own this vehicle**, please fill out and return mail the enclosed card so that you will not be contacted again about this recall.

### **IF YOU NEED FURTHER ASSISTANCE**

If you believe that Navistar has failed to remedy the defect without charge or within a reasonable time, please follow the procedure described in the Owner Assistance Guide section in your Owner's Manual or call toll free 1-800-448-7825.
