

IMPORTANT RECALL NOTICE

Dear Mr. Sam Sample,

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Volvo has decided that a defect which relates to motor vehicle safety exists in certain Volvo vehicles equipped with Garmin növi® 760 portable GPS units. Our records indicate that you may have purchased a Volvo S80 MY2000-2010, S60 MY2001-2009, V70 MY2001-2010, XC70 MY2001-2010, XC90 MY 2003-2010, S40 MY2004-2010, V50 MY 2005 – 2010, C30 MY2007-2010 or C70 MY 2006-2010 equipped with a Garmin növi® 760 unit that is potentially affected by this recall, or purchased a Garmin növi®760 unit directly from a Volvo retailer.

The reason for the Garmin Recall:

Garmin has identified potential overheating issues when certain batteries manufactured within a limited date code range are used in certain Garmin növi® 760 models with a specific printed circuit board (PCB) design. It appears that the interaction of these factors can increase the possibility of overheating, which may lead to a fire.

Volvo is contacting potentially affected vehicle owners and requesting that they visit the Garmin website to identify if their unit is affected.

What you need to do:

Please stop using your Garmin portable GPS device immediately, and visit the Garmin website below to determine if your unit is affected. Vehicle owners should not visit a Volvo retailer for this Garmin recall repair.

If you do not have access to the web site, please call Garmin at 866-957-1981 to determine if your GPS unit is affected and receive instructions on how to have it repaired.

Corrective action:

If you determine that your növi® 760 is affected by this recall, immediately stop using the device, discharge the unit according to the instructions below and return it to the directed Garmin-authorized service center for service.

Do not attempt to remove the battery yourself. Promptly discharge the battery in any recalled n\u00fcvi\u00df 760 devices to eliminate the possibility of the battery overheating. To safely discharge the battery, perform the following actions in order:

- 1. Disconnect the növi® 760 from all power cables and mounts.
- 2. Turn on the növi® 760. The top right corner of the növi® 760 main menu displays the battery symbol and indicates the current battery charge level.
- 3. Let the növi® 760 sit until the battery is completely discharged and the növi® 760 turns itself off
- 4. Do not re-charge or continue to use a recalled növi® 760.

After you discharge your növi® 760 battery, follow the instructions you received from Garmin for returning your növi® 760.

The unit's battery will be replaced with a new battery and a spacer will be inserted on top of the battery next to the PCB. The insertion of the spacer will provide a uniform enclosure space for the replacement battery. When the battery is replaced and the service concluded, your növi® 760 will be returned to you by Garmin. You will not have to pay for any associated service or shipping charges according to instructions by Garmin. www.garmin.com/nuvibatterypcbrecall.
