IMPORTANT MOTORCYCLE SAFETY RECALL

Replacement of Engine Oil Filler Plug/Dipstick

Sprint ST 1050 & Sprint GT 1050

Affected VIN Range: 466932 to 473902

This notice is being sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Triumph Motorcycles has decided that a defect which relates to motor vehicle safety exists on certain Triumph Sprint ST & Sprint GT 1050 motorcycles.

In line with our commitment to quality improvement and customer care, we write to inform you that a limited number of Triumph Sprint ST & Sprint GT motorcycles require the replacement of the engine oil filler plug/dip stick fitted to the clutch cover.

Our records indicate you are the owner of a Sprint ST or Sprint GT 1050 – **VIN SMT601PK8BJ470556**.

We require your co-operation to ensure your bike is modified without delay. This will involve the fitment of a new filler plug/dip stick. This will ensure that your engine oil level can be accurately monitored in the future. We urge you to contact your local Triumph dealer immediately to arrange an early appointment with the service department. The modification is not likely to take more than a few minutes and will be free of charge.

If you had this repair performed before you received this letter, you may be eligible to receive reimbursement for the cost of obtaining a pre-notification remedy of the problem associated with this Recall. Please provide a paid invoice to an authorized Triumph dealer, or directly to Triumph Customer Service, 385 Walt Sanders Memorial Drive, Suite 100, Newnan, GA 30265.

Federal regulations requires that any vehicle lessor receiving the Recall Notice must forward a copy of the notice to the lessee within 10 (ten) days of receipt.

Should you need to discuss any aspect of the Recall, please contact your dealer, who has been advised of this action and who will be able to answer your concerns. If necessary you can of course contact our Customer Service Department at (678) 539 – 8782.

May we take this opportunity to apologize for any inconvenience this may cause, but we are confident you can appreciate the importance of having a safe and reliable vehicle.
