Keystone RV Company ("Keystone") has decided that a defect which relates to motor vehicle safety exists in the recreational vehicles listed below, and is furnishing notification to the National Highway Traffic Safety Administration in accordance with 49 CFR Part 573 Defect and Noncompliance Reports.

- B. Description of Defect. It has been decided certain Atwood 35 Series Range Ovens manufactured before September 20, 2010 with model numbers beginning with RV1735, RV2135, or RA2135 and installed as original equipment on Keystone recreational vehicles may contain non-complying oven gas lines. A potential exists for a small fracture within the line delivering gas to the oven cavity burner. Such a fracture has a potential to leak when the oven burner has gas flowing to it and leads to an increased risk of propane gas build up. A propane leak, in the presence of an ignition source, could result in a fire and/or explosion causing property damage and/or personal injury.

Gas is only supplied through this line when the oven cavity is in use, and thus the potential does NOT exist for a gas leak while the range top burners only are lit or when the range oven controls are off. As such, until the subject unit has been inspected and/or repaired, the oven cavity of all range ovens included in the recall population are not to be lit and used. Customers can continue to use the range top burners as normal.

- C. Basis for Determining that a Defect Exists. Keystone was notified by Atwood Mobile Products in a letter dated September 24, 2010.

- D. Remedying of Defect. The remedy is to isolate and perform a drop pressure test on the oven supply tube. If the tube leaks, it will be replaced.
- E. Owner Notifications. Keystone will notify the owners of the recreational vehicles by letter beginning on October 22, 2010 pending NHTSA approval. A final copy of the owner letter will also be provided to NHTSA, along with the dealer repair procedures.
- F. Quarterly Reporting Requirements. Keystone will be filing quarterly reports in connection with this recall campaign.
- G. Campaign Number. Keystone's identification code for this recall is 10-148.
