The Norcold refrigerator that is the subject of the recall (model 1200AC) was only installed in two vehicles.

Other similar vehicles did not get the same refrigerator.

Identify the approximate percentage of the production of all the recalled models manufactured by your company between the inclusive dates of manufacture provided above, that the recalled model population represents. Three vehicles were built during the period beginning on February 5, 2007 and ending with on July 7, 2007.

Two of them received a Norcold 1200AC refrigerator. The third vehicle did not receive a recalled refrigerator.

Therefore, 66% of the vehicles built during that time period received the recalled refrigerator.

The recall population was determined by researching our records to identify which vehicles received a Norcold refrigerator with any of the following model numbers: 1200AC, 1200ACIM, 1200LR, 1200LRIM, 1201LRIM, 1210AC, 1210ACIM, 1210, 1210IM and 1211IM. It was determined that only two vehicles ever built by Geomarc, Inc. that received a Norcold refrigerator with any of the above model numbers. Both of those vehicles received a Norcold refrigerator having model number 1200AC.
