According to Daimler the remedy is unknown at this time. Repairs will be performed by Daimler Trucks N. America dealerships + Direct Warranty customers i.e., customers approved by Daimler to do their own warranty repairs. Customer notification will be done by first class mail using Daimler Trucks records to determine the customer's affected.
