Dear Mr. Smith:

On July 15, 2011, Fleetwood RV, Inc., decided that a non-compliance to the requirements of Part 567 "Certification" exists in certain motor homes as listed below, and is furnishing notification to the National Highway Traffic Safety Administration in accordance with 49 CFR Part 573 Defect and Non-compliance reports.

The following is the information required by 49 CFR Part 573:

- This report was prepared on July 20, 2011.
  - Fleetwood RV has assigned **110715FRV** as an identification code to this recall.
- (1) The affected motor homes were manufactured by the following wholly owned subsidiary of Fleetwood RV, Inc.

The January 5, 2011, date coincides with correct Federal Certification Tags being applied to the motor homes during production, as a result of a correction to a computer software program that produces the tags.

These motor homes were built with a Fleetwood RV identification number range of:

- (3) Fleetwood RV reports approximately 220 as the number of model year 2009 American Allegiance, American Heritage, Revolution LE; model year 2010 American Eagle, American Heritage, and model year 2011 American Eagle, American Heritage, American Tradition, Discovery, Providence, and Revolution LE, Class A motor homes containing the non-compliance.
- (4) Fleetwood RV estimates that 100% of the affected model 2009 American Allegiance, American Heritage, Revolution LE, model year 2010 American Eagle, American Heritage, and model year 2011 American Eagle, American Heritage, American Tradition, Discovery, Providence, and Revolution LE, Class A motor homes contain the non-compliance.
- (5) On motor homes affected by this recall, the Federal Certification Tag figures related to the intermediate and rear tire pressure ratings, in kilopascals (KPA), were printed in their reversed positions. Tire pressure ratings in pounds per square inch (PSI) are correct.
- (6) Not applicable.
- (7) Fleetwood RV began an investigation in June 2011 after discovering the error.
- (8) Fleetwood RV will mail corrected Federal Certification Tags to dealers and owners of record. We will ask that they deface the original Federal Certification Tag and replace it with the new, serial number specific tag. Owners who are not comfortable installing these labels will be asked to contact a Fleetwood RV dealer to have this service performed at no charge.
- (9) Fleetwood RV intends to conduct a dealer notification by e-mail in August 2011.

Fleetwood RV intends to conduct a customer notification in August 2011.

Fleetwood RV does not foresee any problems with implementing this voluntary recall campaign.

(10) Copies of subsequent correspondence will be submitted to the NHTSA within five (5) working days of distribution. This correspondence will include:

- I) Letter of dealer notification
- II) Letter of customer notification
- III) Service Bulletin
