Vehicles manufactured from May 1, 2010 through January 31, 2011 with the Fontaine Ultra LT fifth.

There are one hundred five vehicles in total affected of which Fontaine has already repaired ninety five of the vehicles. **The remainder, ten vehicles, will be addressed under this safety recall.**

The percentage of the vehicles expected to contain the condition is unknown.

573.6(c)(5)

According to Fontaine, “during the coupling process with the Ultra LT model fifth wheel it is possible for the driver to partially close the fifth wheel lock, and if solely relying on a tug test (pull test), may think that the fifth wheel lock is properly coupled to the trailer king pin when in fact it is not properly coupled.” If the driver drives away with a trailer that is not properly coupled, the trailer can come loose and potentially result in a vehicle accident.

Mack Trucks will initiate a voluntary owner notification, and recall all affected vehicles.

The recall repair will consist of replacing the lock bar.

Reimbursement for cost incurred by the owner for "prenotification remedies" will be addressed on a case-by-case basis according to the "General Plan for Reimbursement of Pre-notification Remedies" which was published December 8th, 2004.

The number, which has been assigned to this recall by Mack Trucks, is **SC0358**

A Safety Recall Alert will be released to dealers on or before September 8, 2011, which informs the dealers of the recall. Owner letters will be mailed on or before September 30, 2011. An advance copy of the owner letter will be submitted to NHTSA for review and approval prior to release to the owners.
