573.6 (c) (3) Number of Vehicles Potentially Containing the Defect

30,294 vehicles are potentially affected by this defect in the United States.

# 573.6 (c) (4) Percentage of Vehicles Actually Containing the Defect

100% of affected vehicles contain the defect.

#### 573.6 (c) (5) Description of Defect

On some 2011-2012 Jetta sedan (6<sup>th</sup> Generation) vehicles with port-installed Volkswagen accessory stainless steel exhaust tips (part number 1K0 071 910 U), the exhaust tips can extend beyond the original length of the factory-installed exhaust pipes. Due to the extra length added by the accessory exhaust tips, there is an increased risk of being burned.

## 573.6 (c) (6) Basis for Determination

July 2011: Volkswagen received complaints of burns resulting from Volkswagen accessory stainless steel exhaust tips (part number 1K0 071 910 U) that extended beyond the original length of the vehicle's exhaust pipes. Based on these complaints, Volkswagen began an investigation.

August 30, 2011: Determination of safety defect was made.

#### 573.6 (c) (7) Noncompliance Test Result

#### 573.6 (c) (8) Proposed Remedial Program

Dealers will inspect affected vehicles to determine if they have Volkswagen accessory stainless steel exhaust tips (part number 1K0 071 910 U). As necessary, replacement stainless steel exhaust tips will be installed. This work will be performed free of charge.
