

Safety Recall Notice

Voltage[®]

Dear Customer:

This **Notice** is sent to you in accordance with the requirements of the United States National Traffic and Motor Vehicle Safety Act.

Reason for This Recall

Dutchmen Manufacturing, Inc. (Dutchmen) has decided that a defect which relates to motor vehicle safety exists in certain *Voltage* brand travel trailers manufactured between January 3, 2011 and July 8, 2011. Other trailer models manufactured by Dutchmen Manufacturing, Inc. during this time period are not included in this recall.

It has been decided The vehicles subject to this recall campaign were manufactured with fuel supply and fuel return hoses that may contain a splice in the fuel line. These lines should be continuous run through a PVC pipe that runs from the fuel tank to the generator. This condition was discovered after a supplier change. Bulk spools of fuel line have been found to contain a random splice that is evident by yellow tape joining two ends. A limited number of Voltage units may contain lines that have a splice. Lines that contain a splice may eventually leak fuel, which could result in a potential fire.

What We Will Do

Dutchmen representatives have been in contact with the staff at your selling dealership regarding this situation. The remedy is to inspect the fuel lines between the fuel tank and the generator. If found to have a splice, the fuel lines will be replaced. The service and parts required for this corrective action will be provided at no charge to you.

What You Should Do

At your earliest convenience, please make an appointment to have your RV serviced by your dealership. The labor time to perform this correction is approximately one hour. Please ask your dealer if you wish to know how much additional time will be needed to schedule and process your RV for this repair. Your dealer is best equipped to obtain parts and provide service to ensure your RV is corrected as promptly as possible.
