## SAFETY RECALL G-11518

OCTOBER 2011

Dear IC Bus Customer,

This notice is being sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

IC Bus has decided that a defect which relates to motor vehicle safety exists in certain BE and CE model school buses built 6/27/06 thru 3/23/11 with a MaxxForte 7 engine feature code 12NTH, 12NTD, 12NTE, 12NTG, 12VYY, or 12627 and alternator feature code 0008GGR, 0008GGM, 0008GWX, or 0008GEL.

### **REASON FOR THIS RECALL**

The positive alternator cable may rub on the engine control module mounting bracket possibly compromising its insulation causing an electrical short.

### **RISK TO MOTOR VEHICLE SAFETY**

An electrical short may cause a fire possibly resulting in property damage, personal injury, or death.

### **DEFECT REMEDY**

The repair will involve the inspection and replacement, if necessary, of the alternator cables and the installation of tie straps to route the alternator cables away from the engine control module bracket. Dealers have parts and instructions to repair your vehicle. The repair will be performed free of charge and take approximately 60 minutes to complete.

### **ACTIONS YOU SHOULD TAKE**

IC Bus' records indicate that you own a vehicle involved in this recall. The vehicle is identified on the enclosed card.

**If you own this vehicle**, please schedule an appointment with any IC Bus dealer to have your vehicle repaired. You can find your nearest dealer by calling 1-800-448-7825 or by using the dealer locator at <http://www.icbus.com>.

**If you have already paid for repairs that corrected the defect**, you may be eligible for reimbursement of certain repair expenses. Present your original repair paperwork and proof of payment to any IC Bus dealer and your eligibility will be reviewed. You may also submit a claim using the enclosed Request for Reimbursement card.

**If you are the lessor of this vehicle**, please forward a copy of this notice to the lessee within ten days to comply with federal regulations.

**If you do not own this vehicle**, please fill out and return mail the enclosed card so that you will not be contacted again about this recall.

### **IF YOU NEED ASSISTANCE**

If you believe that IC Bus has failed to remedy the defect without charge or within a reasonable time, please follow the procedure described in the Owner Assistance Guide section in your Owner's Manual or call toll free 1-800-448-7825.
