

Safety Recall Notice

Rubicon®

Dear Customer:

This **Notice** is sent to you in accordance with the requirements of the United States National Traffic and Motor Vehicle Safety Act.

Reason for This Recall

Dutchmen Manufacturing, Inc. (Dutchmen) has decided that a defect which relates to motor vehicle safety exists in certain *Rubicon* brand travel trailers manufactured at our Burley, Idaho facility between December 8, 2010 and July 15, 2011. Other trailer models manufactured by Dutchmen Manufacturing, Inc. during this time period are not included in this recall.

It has been decided the vehicles subject to this recall campaign may have been manufactured with the exterior furnace vent not installed in the sidewall of the trailer. The furnace can run without the proper exhaust ventilation and release carbon monoxide to the interior of the unit resulting in asphyxiation or carbon monoxide poisoning. The heat build up from the exhaust can also result in a fire.

What We Will Do

Dutchmen representatives have been in contact with the staff at your selling dealership regarding this situation. The remedy is to inspect your trailer to insure it has the proper furnace exhaust installed. If it does not have the furnace vent, the vent will be installed on your trailer. The service and parts required for this corrective action will be provided at no charge to you.

What You Should Do

Do not use the furnace in your trailer. At your earliest convenience, please make an appointment to have your RV serviced by your dealership. The labor time to perform this correction is approximately two hours. Please ask your dealer if you wish to know how much additional time will be needed to schedule and process your RV for this repair. Your dealer is best equipped to obtain parts and provide service to ensure your RV is corrected as promptly as possible.
