NISSAN IS RECALLING CERTAIN MODEL YEAR 2012 TITAN AND ARMADA VEHICLES, MANUFACTURED FROM AUGUST 12, 2011 THROUGH MARCH 13, 2012. THE PART 567 CERTIFICATION LABELS ON THE VEHICLES DO NOT CONTAIN RIM SIZE INFORMATION, AS WELL AS TIRE SIZE AND TIRE PRESSURE INFORMATION. THUS, THESE VEHICLES FAIL TO COMPLY WITH THE REQUIREMENTS OF FEDERAL MOTOR VEHICLE SAFETY STANDARD NO. 110, "TIRE SELECTION AND RIMS."

THE MANUFACTURER IS PETITIONING NHTSA FOR A DETERMINATION THAT THIS MATTER IS INCONSEQUENTIAL TO MOTOR VEHICLE SAFETY. THE MANUFACTURER IS NOT OBLIGATED TO CONDUCT AN OWNER NOTIFICATION AND REMEDY CAMPAIGN UNTIL NHTSA HAS RESOLVED THIS PETITION. IF THE PETITION IS DENIED, THE MANUFACTURER WILL BE NOTIFIED AND MUST THEN UNDERTAKE ITS NOTIFICATION AND REMEDY CAMPAIGN OBLIGATIONS.

Under 49 U.S.C. § 30112(a), it is illegal for anyone, including a manufacturer, distributor, dealer, or retailer to sell an item of equipment or vehicle that fails to comply with all applicable Federal motor vehicle safety standards.
