## 573.6(c)(6): Chronology of Principal Events Leading to Determination of a Safety Defect

- The first field report was generated on November 17, 2011 as a result of a warranty claim and an investigation was initiated.
- It was determined that the $245 / 45 Z-R 20$ All Season Performance tire was a new release for the 2012 model year Dodge Charger SRT8 and the Chrysler 300 SRT8 vehicles.
- The Tire Pressure Monitoring System (TPMS) parameters are programmed into the vehicle's Central Body Controller (CBC) at the vehicle assembly plant based on the vehicle tire sales code.
- For 2012 model year, the SRT8 tire sales code information was not included in the CBC configuration software.
- Since the CBC configuration in the suspect vehicle population did not include a cold inflation value, a TPMS telltale would only trigger if the tire pressure fell below a default value of 22 psi.
- FMVSS 138 requires illumination of the low tire pressure telltale when the inflation pressure in one or more of the vehicle's tires is equal to or less than the pressure 25 percent below the cold inflation pressure indicated on the placard label.
- For the $245 / 45 Z-R 20$ AS Performance tire, the cold inflation pressure is 32 psi , which yields a minimum tire pressure of 24 psi before the telltale is activated.
- On November 17, 2011, Brampton Assembly Plant initiated a corrective action that insures all tire sales codes are accounted for in the CBC configuration.
- Chrysler Group LLC is unaware of any accidents or injuries related to this condition.
- This information was presented to the Vehicle Regulations Committee on December 21, 2011, which decided to conduct a voluntary safety recall on all affected vehicles.

## 573.6(c)(8): Description of Remedy

Conduct a voluntary safety recall to program the correct tire placard pressures into the vehicle's Central Body Controller on all affected vehicles.

Chrysler has a longstanding policy and practice of reimbursing owners who have incurred the cost of repairing a problem that subsequently becomes the subject of a field action. To ensure consistency, Chrysler, as part of the owner letter, will request that customers send the original receipt and/or other adequate proof of payment to the company for confirmation of the expense.
