

Bloomer Trailers was notified by Southwest Wheel on 12/22/11 about the Dexter Recall. We then took those serial #'s provided of the recalled Dexter Actuators and compared them to the list of serial #'s we record when issuing actuator units to the trailers being built. We went back one year in our log to locate recalled Dexter actuators. Files for trailers with recalled Dexter Actuators were then pulled. We used the information from the files to contact the Bloomer Dealers, Living Quarters Companies by email. The three trailers with recalled actuators that customer had were also contacted and notified of the recall and through Dexter had actuators shipped to them directly and installed at no cost. The remaining 20 units were either located at the Bloomer Trailer factory, Living Quarters Companies or Dealer Lot. All of the 20 units have been replaced. I have attached a spreadsheet with this information
