Pierce has been notified by Daimler Trucks North America LLC of a potential safety defect with the pump to rail High Pressure Fuel Line (HPFL) support system used on Pierce custom fire trucks with Detroit DD13 EPA 2007 and EPA 2010 diesel engines. Therefore, Pierce has decided that a defect which relates to motor vehicle safety exists in the motor vehicles listed below. We therefore furnish notification to the National Highway Traffic Safety Administration, in accordance with 49 CFR Part 573, Defect and Noncompliance Reports.


7. Corrective Action:
