Dear Ms. Lewis:

On December 3, 2012 Honda Motor Co., Ltd. (HMC) determined that a potential defect relating to motor vehicle safety exists in the ignition interlock of certain 2003-2004 model year Honda Pilot and Honda Odyssey automobiles and 2003-2006 model year Acura MDX automobiles, and is providing notification to the National Highway Traffic Safety Administration in accordance with 49 CFR Part 573 Defect and Noncompliance Reports.

Description of the basis for the determination of the recall population:

The recall population was determined based on manufacturing records. The VIN range reflects all possible vehicles that could potentially experience the problem.

Defect description:

A design change to the ignition switch applied to these vehicles reduced the range of rotation for the ignition switch from 160° in earlier designs to 125° for these vehicles. with no corresponding change to the ignition interlock blocking mechanism. As a result, the driver may apply excessive rotational force on the ignition key when attempting to remove the key when the gear selector is not in the Park position, potentially damaging a lever in the ignition interlock blocking mechanism. If the ignition interlock lever is damaged, it may become possible for the driver to remove the ignition key when the gear selector is in a position other than the Park position. If the ignition key can be removed when the gear selector is not in the Park position the vehicle may roll away, increasing the risk of a crash.

Oct 2, 2012 AHM received the opening resume for Preliminary Evaluation (PE12-026) from NHTSA.

Oct 25, 2012 Initial meeting held within Honda to review claim data and begin

analysis to compare the ignition switches of subject vehicles to

other models.

Nov 27, 2012 North American Quality Committee proposed market action.

Dec 6, 2012 HMC determined that a safety related defect exists and decided to

conduct a safety recall.

In support of PE12-026 Honda has determined that we have received the following:

252 warranty claims from August 14, 2003 to September 30, 2012 for Odyssey, Pilot and MDX:

Excluding the MDX (which was not subject to PE12-026 and has not been investigated by Honda beyond our examination of warranty records) Honda has counted the following for the affected Odyssey and Pilot vehicles:

- 19 field reports, including one allegation of a crash, from February 6, 2008 to September 30, 2012;
- 113 customer complaints, including 2 allegations of injuries and 27 allegations of crashes, from November 3, 2003 to September 30, 2012.

Program for remedying the defect:

The owners of all affected vehicles will be contacted by mail and asked to take their vehicle to a Honda or Acura automobile dealer. The dealer will install an updated shift interlock lever and, if necessary, replace the ignition switch, free of charge.
