Certain Model Year 2012 S60, XC60, S80 and XC70 Vehicles

The sale or lease of defective or non-compliant motor vehicles or equipment is prohibited by law. Vehicles in retailer inventory must be remedied prior to sale. Repair information is attached to this communication.

Volvo Cars of North America, LLC (Volvo) has decided to conduct a voluntary safety recall on certain model year 2012 S60, XC60, S80 and XC70 vehicles.

Volvo has identified that the wiring harness under the driver and or passenger front seat may not have been properly secured to the seat frame during vehicle assembly. The wiring harness under the front seat on affected vehicles may get caught on the audio or back up camera amplifier when the front seat is adjusted. If this condition occurs, the wiring harness connector may detach and the Supplemental Restraint System (SRS) may not function as intended. The SRS warning lamp in the instrument panel will illuminate and the message "SRS service required urgent" will be displayed in the Driver Information Module (DIM).

The following components may be affected:

- Seat belt buckle, if the signal is absent the front airbag(s) will deploy as if the person in the seat is unbelted.
- Side Impact Protection System (SIPS), if signal is absent the side impact air bag will not deploy.
- Occupant Weight Sensor (OWS) (only on front passenger seat), if signal is absent the SRS system will not deploy the passenger front airbag due to that it cannot determine if a small person/child seat is present or not in the passenger seat.
- Seat Track Position Sensor (STPS), if signal is absent the SRS system cannot determine the position of the seat and the front air bag will deploy with full power.
- Pelvis Lap Protection (PLP), if signal is absent the lap belt pretensioner will not deploy.

The corrective action will be to inspect the seat wiring under both front seats, and **if necessary** secure the wiring per TJ 26012.

## **OWNER NOTIFICATION**

Owner notification is scheduled to begin in March.

## RETAILER RESPONSIBILITIES

Retailers must perform this recall campaign on eligible vehicles regardless of miles/kilometers or vehicle age. All work performed under this recall is free of charge to the owner. ## B. VEHICLES INVOLVED






Note! Vehicles with Seat Ventilation








