### *Safety Recall Notice*

*Breckenridge, Breckenridge XT (XTendables), Classic Breeze, Perfect Cottage,  
FineLife Cottage, Bayridge, BreckenLodge, Breckenridge KOA Lodge*

Dear Dealer:

This **Safety Recall Notice** is sent to you in accordance with the requirements of the United States National Traffic and Motor Vehicle Safety Act and The Canadian Motor Vehicle Safety Act and is important for your safety.

Breckenridge along with Atwood Mobile Products has decided that a defect which relates to motor vehicle safety exists in certain *Breckenridge, Breckenridge XT (XTendables), Classic Breeze, Perfect Cottage, FineLife Cottage, Bayridge, BreckenLodge, Breckenridge KOA Lodge* brand travel trailers manufactured between May 26, 2009 and May 2, 2012. Other trailer models manufactured by Breckenridge during this time period are not included in this recall.

It has been decided the vehicles subject to this recall campaign have been manufactured with a defective Atwood furnace. The furnaces have been built with a defective gas control valve. These furnaces are model 8935-III and 8940III series AC units manufactured between May 18, 2009 and March 29, 2012. There exists a potential in the defective units for the gas control valve to stick in the open position which could cause a risk of a fire resulting in personal injury or death. Atwood Mobile Products will be directing this recall.

The remedy is to inspect and replace the gas control valve, if necessary. The replacement parts required for this corrective action are readily available through Atwood Mobile Products.
