# SUBJECT: Model X204. Model Year 2013 Software Calibration Number (SCN) Code - Front SAM

Daimler AG (DAG), the manufacturer of Mercedes-Benz vehicles, has determined that the parking lamps on the subject vehicles may be too bright and not meet the requirements of Federal Motor Vehicle Safety Standard number 108. Therefore, MBUSA has initiated a voluntary recall of all potentially affected vehicles described above. An authorized Mercedes-Benz dealer will update the SCN code in the front SAM.

Attached is a sample copy of a letter which owners of the affected vehicles will receive.

Prior to performing this Recall Campaign:

- Please check VMI to determine if the vehicle is involved in the Campaign and if it has been previously repaired.
- Please review the entire Recall Campaign bulletin and follow the repair procedure exactly as described.

- Connect battery charger (battery voltage >12.5V).
- 1. Connect Star Diagnosis to vehicle.
- 2. SCN code SAM-F control module: Control unit / Adaptations / SCN coding.
- 3. Follow on-screen instructions.

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Daimler AG (DAG), the manufacturer of Mercedes-Benz vehicles, has decided that in certain Model Year 2013 GLK-Class vehicles the parking lamps may fail to conform to the requirements of Federal Motor Vehicle Safety Standard (FMVSS) number 108, "Lamps, reflective devices and associated equipment." Our records indicate that your vehicle is included in the affected population of vehicles.

#### WE SENT YOU THIS NOTICE BECAUSE WE ARE CONCERNED ABOUT YOUR SAFETY.

DAG has determined that the level of illumination for the front parking lamps in your vehicle is above the maximum illumination level permitted by FMVSS 108. The higher illumination level may cause glare to oncoming vehicles. An authorized Mercedes-Benz dealer will reprogram your vehicle to lower the illumination level of your front parking lamps.

**This service will be provided free of charge.** We are dedicated to always delivering the Best or Nothing – and respect for your time is a top priority. While the minimum repair time is approximately one half hour, your dealer can provide you with a better estimate of the overall time for this service visit.
