Dear Mitsubishi Fuso Truck Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Mitsubishi Fuso Truck of America, Inc. has decided that a defect which relates to motor vehicle safety exists in the parking brake lock nut. On certain vehicles, the parking brake cable lock nut may have been improperly tightened during vehicle assembly and could loosen over time, allowing the parking brake lever stroke length to increase gradually. If left unchecked, the parking brake stroke could increase until the parking brake no longer fully applies. This could allow the vehicle to roll away causing a risk or property damage and/or personal injury.
