## SAFETY RECALL M36 / NHTSA 12V-560

Seating Capacity Label

Dear: (Name)

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Chrysler has decided that some **2013 model year Dodge Durango** vehicles fail to conform to the requirements of Federal Motor Vehicle Safety Standard No. 110, "Tire Selection and Rims for Motor Vehicles with a GVWR of 10,000 pounds or less".

*The problem is...* The Seating Capacity label on your vehicle (VIN: xxxxxxxxxxxxxxx) contains incorrect seat capacity information. This can cause improper loading of the vehicle and result in a crash without warning.

What you must<br/>do to ensure your<br/>safety...> We ask that you apply the enclosed Overlay label over the seating section of<br/>the Tire and Loading Information label as described on the reverse side of<br/>this letter.

If preferred, you may contact your dealer to schedule a service appointment for installation of the label. The service will be provided free of charge and should only take a few minutes to complete. However, additional time may be necessary depending on service schedules. Bring the enclosed labels and this letter with you to your dealer. The letter identifies the required service to the dealer.

Please help us update our records by filling out the attached prepaid postcard, if any of the conditions listed on the card apply to you or your vehicle. You may also update this information on the web at www.dodge.com/ownersreg.

If you have already experienced this condition and have paid to have it repaired, please send your original receipts and/or other adequate proof of payment to the following address for reimbursement: Chrysler Customer Assistance, P.O. Box 21-8007, Auburn Hills, MI 48321-8007, Attention: Reimbursement. Once we receive and verify the required documents, reimbursement will be sent to you within 3 weeks.

## **Installation Instructions for Seating Capacity Overlay Label**




Figure 1 – Driver's Side Front Door Shown

- 1. Open the driver's door and locate the Tire and Loading Information label on the driver's side "B" pillar as shown in Figure 1.
- 2. Clean the existing Tire and Loading Information label with alcohol / glass cleaner or equivalent and a soft cloth to remove any dirt, oil residue or grease.
- 3. Remove the enclosed Overlay label from its paper backing and carefully install it over the seating section of the Tire and Loading Information label (Figure 2). Firmly press and smooth the label to the surface of the existing Tire and Loading Information label to ensure good adhesion.
