- What is the Issue? On your vehicle, it may be possible that when the transmission gearshift lever is placed in reverse, the electronic transmission PRNDL display (if equipped) may not indicate "R" (reverse) and the back-up lamps may not operate. These conditions increase the risk of a crash or a pedestrian being struck due to the lack of reverse lamp illumination. Additional symptoms that may be experienced intermittently include the vehicle does not move when reverse gear is selected and inoperative rear video camera.
