According to our records, your 2013 Escape has not had necessary safety recall repairs made. We urge you to have the free repair performed at your local dealership as soon possible.

**Recall Number 12S34 - Console Trim Panel Clearance to Pedals**  
**and Description:**

**What is the Issue?** On your vehicle, the carpet spacer may have been mispositioned during installation, reducing the clearance between the Brake Pedal and the floor console. In certain vehicles, reduced clearance in this area may result in the operator's foot contacting the side of the Brake Pedal while transferring the foot from the Accelerator Pedal to the Brake Pedal, potentially increasing stopping distance and increasing the risk of a crash.

**Recall Number 12S35 - Fuel Line Replacement**  
**and Description:**

**What is the Issue?** On your Escape vehicle equipped with a 1.6L engine, an engine compartment fuel line may have been damaged during the manufacturing process. When the engine is running, a damaged fuel line may quickly result in a significant fuel leak. In the presence of an ignition source, this fuel leak poses a risk of fire.

**Recall Number 13S12 - Risk of Localized Overheating of the Engine Cylinder Head**  
**and Description:**

**What is the Issue?** On your vehicle, localized overheating of the engine cylinder head may cause the cylinder head to crack, causing an oil leak that may result in a fire in the engine compartment (NHTSA Recall 13V-583).

**Recall Number and Description: 14S04 - Reprogram Restraints Control Module**

**What is the Issue?** On your vehicle, a software concern may cause a delay in the deployment of the safety canopy in certain roll-over circumstances, potentially increasing the risk of injury.

**Recall Number and Description: 14S03 - Exterior Door Handle Inspection and Adjustment**

**What is the Issue?** On your vehicle, the exterior door handle may have been misaligned to the door outer panel during assembly. A misalignment of the handle may cause internal interference and a binding condition. This may result in a door which is difficult to close, or potentially opens while driving, increasing the risk of injury to an occupant.

**What Are We Asking You To Do?** Please contact your dealer to schedule an appointment to have these important service procedures completed.
