SAFETY RECALL 2nd NOTICE -12526

OCTOBER 2014

Dear INTERNATIONAL® Customer,

This notice applies to your vehicle identified on the enclosed card and is being sent to you in accordance with the requirements of the National Highway Traffic Safety Administration and the Motor Vehicle Safety Act.

This is a safety recall follow-up notification to the initial notice mailed in November 2012. Company records indicate the vehicle identified on the enclosed Authorization for Recall Service card has not been repaired. If it has been repaired, please fill out and return mail the card so you will not be contacted again about this recall.

Navistar has decided that a defect which relates to motor vehicle safety exists in certain 3200IM and HC model buses built 04/11/06 thru 12/11/09 with parking brake code 04GAY.

REASON FOR THIS RECALL

If there is a failure of one of the parking brake system components which leads to loss of air pressure, it can lead to possible inadvertent partial/total parking brake application while the vehicle is in motion.

RISK TO MOTOR VEHICLE SAFETY

Parking brake may apply total or partial pressure without warning and may contribute to a vehicle crash which may result in property damage or personal injury.

DEFECT REMEDY

The repair will involve the update of the parking brake system to include an 85 PSI pressure switch to detect brake lever movement and set a warning light to warn the driver of possible application. Dealers have parts and instructions to repair your vehicle. The repair will be performed free of charge and take approximately 60 minutes to complete.

ACTIONS YOU SHOULD TAKE

Navistar's records indicate that you own a vehicle involved in this recall. The vehicle is identified on the enclosed card.

If you own this vehicle, please schedule an appointment with any INTERNATIONAL® dealer to have your vehicle repaired. You can find your nearest dealer by calling 1-800-448-7825 or by using the dealer locator at <http://www.internationaltrucks.com>.

If you have already paid for repairs that corrected the defect, you may be eligible for reimbursement of certain repair expenses. Present your original repair paperwork and proof of payment to any INTERNATIONAL® dealer and your eligibility will be reviewed. You may also submit a claim using the enclosed Request for Reimbursement card.

If you are the lessor of this vehicle, please forward a copy of this notice to the lessee within ten days to comply with federal regulations.

If you do not own this vehicle, please fill out and return mail the enclosed card so that you will not be contacted again about this recall.

IF YOU NEED FURTHER ASSISTANCE

If you believe that Navistar has failed to remedy the defect without charge or within a reasonable time, please follow the procedure described in the Owner Assistance Guide section in your Owner's Manual or call toll free 1-800-448-7825.
