#### 12C26 - Reprogram Restraint Control Module

### What is the Issue?

On your vehicle, the side air curtain does not perform as described in the vehicle owner guide, as required by FMVSS 208. Your vehicle was designed so that when the front passenger seat is empty, the passenger side air curtain will not deploy during a side impact collision. As a result, an occupant in the right rear seating position will not have coverage from the side air curtain in a crash if the front passenger seat is empty, increasing the risk of injury to the right rear occupant.
