Problem Description:

North American Bus Industries, Inc. (NABI) is recalling certain model year 2012-2013 40LFW and model year 2013 31LFW transit buses manufactured October 5, 2012, through May 15, 2013 and equipped with a rear mount Suttrak electric HVAC. The fuse holder inside the HVAC may allow voltage spikes, which may damage electrical components.

Consequence:

Damage to electrical components may result in a fire.

Remedy:

NABI will notify the fleet owner of the affected buses and dealers will replace the cables and fuse holders for the HVAC system, free of charge. The recall is expected to begin in early July 2013. NABI's recall number is 20135. Owners may contact NABI at 1-256-831-4296.

Please be reminded of the following requirements:

You are required to submit a draft owner notification letter to this office no less than five days prior to mailing it to the customers. Also, copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
