## **VOLUNTARY 573.6 REPORT**

As part of Kia's continued investigation of the stop lamp switch issue, Kia has expanded the scope of Recall 13v114 as indicated below.

### **573.6(C) (2)**

Identification of Vehicle, Make,  
Model Year and Manufacturing

The following models totaling 356,719 vehicles are being added to the current recall:

Approximately 22,661 model year 2009 Borrego vehicles manufactured from May 2, 2008 through January 20, 2009.  
Approximately 96,824 model year 2010 Forte vehicles manufactured from February 24, 2009 through September 6, 2010.

Approximately 108,116 model year 2008-2010 Optima vehicles manufactured from May 31, 2007 through April 29, 2010.

Approximately 36,101 model year 2011 Sportage vehicles manufactured from May 6, 2010 through March 6, 2011.  
Approximately 9,966 model year 2007-2009 Amanti vehicles manufactured from November 21, 2006 through June 2, 2008.

Approximately 83,051 model year 2008-2011 Sedona vehicles manufactured from June 2, 2007 through December 31, 2010.

### **573.6(C) (8) (ii)**

Estimate Date for Notification of Defect

The estimated date of notification to dealers of the expanded recall scope is sometime in October, 2013.

Notification to the owners of the additional vehicles included in this recall will occur beginning sometime in October, 2013.
