The VSA system on certain 2012-2013 model year Honda Fit Sport vehicles equipped with certain tires may allow yaw rates that exceed the FMVSS 126 test standards at high steering wheel angles, causing the vehicles to fail to comply with S5.2.1 and S5.2.2 of FMVSS 126.

Chronology:

March 20, 2013 NHTSA notified AHM that the 2013 model year Honda Fit Sport

failed an FMVSS 126 indicant test and that measurement

equipment used in the test had expired calibration. A re-test was

scheduled for April 9, 2013.

March 21, 2013 Honda initiated an investigation for non-compliance.

April 9, 2013 NHTSA performed the FMVSS 126 compliance test and the

2013 model year Honda Fit Sport failed.

April 16, 2013 Honda completed the investigation and determined that a non-

compliance exists and decided to conduct a non-compliance

recall.
