## 573.6(c)(5): Description of Defect or Noncompliance

Some Ram $15004 \times 4$ vehicles may illuminate the Electronic Stability Control (ESC) lamp due to a vehicle configuration mismatch, resulting in ESC being disabled. The Diagnostic Trouble Code (DTC) is being caused by the transfer case (T-case) gear position being changed immediately prior to the ignition key being cycled to the OFF position. If the Tcase position was changed before it was written to the ESC EEPROM, but after the checksum was written, then the T-case position stored did not match the Checksum and the DTC occurred due to the configuration mismatch.

## 573.6(c)(6): Chronology of Principal Events Leading to Determination of a Safety Defect

- In February 2013, Chrysler opened an investigation as a result of a small number of warranty conditions related to ESC lamps being illuminated in customer vehicles. The ESC Module was new for the 2013 MY.
- In February 2013, Chrysler was investigating cause. Dealer narratives indicated the lamp was illuminated due to Diagnostic Trouble Code (DTC) C2206 - Vehicle Configuration Mismatch. Once the DTC becomes active, the ESC lamp would illuminate and ESC would be disabled at key ON until the dealer reinitialized the ESC module. To correct the issue, the ESC Module software was modified to only look at the T-case position at ignition ON and not write the position to EEPROM at ignition OFF, eliminating the possibility of a mismatch in T-case position between key OFF / ON.
- Between February and June, 2013 Chrysler monitored field data to confirm the cause.
- In June 2013, scope of the affected vehicle population was finalized.
- During its investigation, Chrysler identified 0 CAIRs, 0 VOQs, and 9 Field Reports reported between December 13, 2012 and June 8, 2013, potentially related to this ESC disabled issue.
- Chrysler is not aware of any accidents or injuries related to this issue.
- On June 25, 2013, Chrysler decided to conduct a voluntary safety recall to flash the ESC module.

Chrysler will conduct a voluntary safety recall flash the ESC Module.
Chrysler has a longstanding policy and practice of reimbursing owners who have incurred the cost of repairing a problem that subsequently becomes the subject of a field action. To ensure consistency, Chrysler, as part of the owner letter, will request that customers send the original receipt and/or other adequate proof of payment to the company for confirmation of the expense.
