Description of the Defect : Toyota is recalling certain model year 2003-2004 Corolla and Corolla Matrix vehicles and 2003-2004 Pontiac Vibe vehicles. The supplemental restraint system (SRS) circuits are susceptible to internal shorting. The electrical short may create an abnormal current flow and increased heat which can damage the circuits. This could result in an inadvertent deployment of the front airbags and/or seat belt pretensioners.

Description of the Safety Risk : Inadvertent deployment of the airbags or the seat belt pretensioners may increase the risk of injury and the possibility of a vehicle crash.

Description of Remedy Program : Toyota will notify their owners, and General Motors will notify theirs. Dealers will install a supplemental harness containing an electrical filter between the airbag control module and its wire harness, free of charge. The recall began on March 13, 2013. For more information, Toyota owners may call 1-800-331-4331 and Pontiac owners may call 1-800-620-7668.

Toyota intends to modify the remedy relating to this recall. All vehicles previously identified will receive new airbag control modules. We intend to re-notify owners of the subject vehicles who have already presented their vehicles for repair and had the noise filter installed but did not receive a new airbag control module, instructing them to return their vehicles for an airbag control module replacement.
