Description of Remedy Program : Interim notices were sent to owners during January 2014. A second letter will be mailed to owners when a permanent remedy for this condition becomes available. Owners may contact Chrysler at 1-800-247-9753. Chrysler's recall campaign number is N63. Update March 30, 2015, FCA US is changing the recall campaign number to R16. The reason is because the N63 recall marked vehicles complete (recall remedy complete) due to the interim inspection/replacement of the tie rod. FCA US is changing the recall campaign number to R16 so all vehicle owners involved in the original N63 recall, will receive new final owner letters informing the owner to schedule a service appointment to have the new recall campaign number R16 complete. With the release of recall R16, the N63 recall will be cancelled assuring all vehicles require the new steering linkage.
