Kia Motors America, Inc. pursuant to the National Traffic and Motor Vehicle Safety Act is conducting a Voluntary Safety Recall Campaign to inspect and repair or replace, if necessary, the front lower control arms on certain 2006-2012 MY Kia Sedona vehicles, originally purchased in, or currently registered in one of the twenty-one (21) salt belt states. There is a possibility that corrosion of the front lower control arms may occur as a result of prolonged exposure to road salt. Over time, if allowed to progress without inspection and corrective action, the lower control arms could break. The salt belt states include:

Enclosed you will find a copy of the owner notification letter and a Q&A Guide for recall questions, both of which describe the issue. A list of retailed Kia Sedona owners affected by this recall can be accessed on WEBDCS. Log onto the site, select the Consumer Affairs Tab, click on Not Completed Recall VINS in the left side menu, and select **SC100** to generate the list.

We will begin mailing notices to the 2009 – 2012 MY Sedona owners on December 20, 2013, and to the 2006-2008 MY Sedona owners on December 30, 2013. Please start performing the inspection immediately on any affected vehicle currently in your inventory to ensure that the front lower control arms are repaired or replaced if necessary, prior to selling the vehicle to a retail customer.

PARTS INFORMATION: <u>During the week of December 20, 2013</u>, affected salt state dealers will receive initial shipments of parts and chemicals, based on the campaign VIN list. Initial order quantities will include parts and chemicals required for initial repairs of affected vehicles retailed out of your dealership. Initial parts will not be automatically shipped to dealerships outside of salt states, or to dealerships with no affected VIN's.

Please make certain the appropriate personnel in your dealership are familiar with the details of this campaign to ensure proper responses to customer inquiries and requests to have the campaign performed on their 2006-2012 MY Kia Sedona vehicles.

NHTSA ADVISORY: It is a violation of Federal law for a dealer to deliver a new motor vehicle covered by this notification under a sale or lease until the defect is remedied.
