



SAFETY RECALL NOTICE – NHTSA NUMBER 13E-007

March 2013

Dear Fulmer Helmet Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Subject: Helmet Recall

Reason For This Recall

Fulmer Helmets has decided that certain helmets sizes of Medium, Large, Extra Large, and 2XL model AF-80, AF-81, and AF-82 in the colors black, flat black, and silver fail to conform to Federal Motor Vehicle Safety Standard No. 218, "Motorcycle Helmets."

The helmets affected are only the model, sizes, and colors noted above produced in July 2008. There is a manufacturer date under the helmet comfort liner that should be checked.

Consequences: In the event of a crash, the helmet may not provide adequate protection to the wearer, possibly resulting in injuries.

Compliance: The problem has been corrected on all Fulmer Medium, Large, Extra Large, 2XL AF-80, AF-81, and AF-82 helmets produced after July 2008. All other helmets are in compliance with all Federal requirements. Rider safety is our top concern and Fulmer Helmets is cooperating fully with National Highway traffic Safety Administration (NHTSA).

What Helmet Owners Should Do

If you own a helmet of the size listed above, check the manufacturer date under the comfort liner inside the helmet to see if the date is July 2008.

If you have an affected helmet, call Fulmer Helmets at 1-800-489-2300 Monday through Friday 8:00 AM to 4:30PM CST. One of our customer service representatives will instruct you how to receive a new helmet.

What Fulmer Will Do

Fulmer Helmets will send you a UPS "call tag" to pick up your helmet at no cost to you after you package it. When we receive your helmet, we will replace your potentially non-compliant helmet with a compliant helmet of the same size and comparable model at no cost to you.

We apologize for this inconvenience but wearer safety is our first concern and we want you to have a safe ride.

Models: Fulmer Helmet models AF-80, AF-81, AF-82
Sizes: Medium, Large, XL, and 2XL
Colors: black, flat black, and silver
Manufactured on July 2008

Summary: The helmets fail to comply or conform to Federal Motor Vehicle Safety Standard No. 218, "Motorcycle Helmets."

Consequences: In the event of a crash, the helmet may not provide adequate protection to the wearer, possibly resulting in injury.

Compliance: The problem was corrected on all helmets produced after July 2008.

Rider safety is our top concern and Fulmer Helmets is cooperating completely with the NHTSA and recalling those helmets for the models with the manufacture date listed above. If you have a Fulmer Helmet model AF-80, AF-81, AF-82 sizes Med, Large, XL, 2XL in colors Black, Flat Black or Silver with a manufacture date of July 2008, return them to Fulmer Helmets for a replacement with a safety-compliant model.

What You Should Do:

- Do not sell any more of the non-compliant helmets.
- Check the date code under the comfort liner.
- Call Fulmer for a Return Authorization of your inventory of the models listed above and a manufacture date July 2008. Call 1-800-489-2300. We will send you a UPS Call Tag to cover the freight.
- Refer your customers who bought the non-compliant helmets to Fulmer at 1-800-489-2300 for a replacement helmet.
- If you replace your customer's helmet, send us the non-compliant helmet and we will send you a new, compliant helmet.

Post the enclosed Consumer Alert Notice in your store.

We regret this inconvenience but are taking this action in the interest of your and our customers' safety. We appreciate your understanding and cooperation.

Enclosed is a notice to consumers that we ask you to post in your store. We also have enclosed a consumer letter that you can mail to your consumers who purchased the affected helmet.
