IMPORTANT RECALL INFORMATION #130102FRV

January 2013

Dear Valued Fleetwood RV Customer:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Fleetwood RV, Inc., on behalf of its subsidiary manufacturing center located in Decatur, Indiana, has decided that the federal certification tags for certain model year 2012 and 2013 Boulder Classic, Model 30T, Class A motor homes fail to comply with the Code of Federal Regulations, Part 567, "Certification" requirements.

WHAT IS THE PROBLEM?

Fleetwood RV, Inc., has become aware that the Federal Certification Tag figures related to the front and rear tire sizes, front and rear tire rim sizes, and front and rear tire pressure ratings, in pounds per square inch (PSI) and in kilopascals (KPA), are incorrect. Owners relying on the information provided on the label may incorrectly inflate their tires, which could contribute to a tire failure that could cause a crash.

WHAT SHOULD YOU DO?

Deface the original Federal Certification Tag and replace it with the new serial number specific Federal Certification Tag enclosed with this letter. You can locate the Federal Certification Tag on the inside sidewall just behind the driver's seat.

Note: Please peel the backing before applying over the defaced originals. Failure to install the corrected label will not meet the requirements of the "Certification" standard.

WHAT WILL FLEETWOOD DO?

If you do not feel comfortable installing the replacement tag, you may take your motor home to any Fleetwood RV dealer and they will perform this service at no charge to you. When you deliver your motor home for repair, your dealer will complete a **Repair Order**, which you will need to sign.

If you have paid to have this concern corrected previously, you may be eligible for reimbursement of your cost for that repair. For more information, please contact Fleetwood Owner Relations at (800) 509-3418.

Upon completion of the installation of the replacement tag by yourself or a Fleetwood RV dealer, please fill out the enclosed self-addressed ***Vehicle Information Update Card*** and return it to Fleetwood RV.

If you have changed your address or sold the motor home, please take a moment to provide the name and address of the person or dealership you sold it to on the enclosed ***Vehicle Information Update Card*** and return it to Fleetwood. This will allow us to update our records and if necessary, notify the new owner using the information you provide.

For leased vehicles - Any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within ten days.
