SAFETY RECALL 13505

Dear INTERNATIONAL® Customer,

This notice is being sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Navistar has decided that a defect which relates to motor vehicle safety exists in certain DuraStar®, LoneStar®, ProStar®, TerraStar®, TranStar®, and WorkStar® model trucks built 1 June 2010 thru 7 March 2012 with day cab codes 16CAB, 16030 or 16196 and sun shade feature codes 16WCE, 16WCR, 16XWD, 16XWE, 16XWV, 16XXB, 16XXD, 16XXE, 16XXG or 16XYN.

REASON FOR THIS RECALL

The adhesive material used to bond the sun shade mount to the cab roof panel may not sufficiently bond the mount to the cab which may result in partial or full separation of the sun shade from the roof panel.

RISK TO MOTOR VEHICLE SAFETY

If the sun shade separates from the cab roof during vehicle operation, it could hit another vehicle on the roadway or cause other vehicles to make evasive maneuvers which could result in a motor vehicle accident or personal injury.

DEFECT REMEDY

The repair will involve inspection of the sun shade mount. Secure mounts will receive eight sealed rivets and the perimeter of the mount resealed. Dealers have parts and instructions to repair your vehicle. The repair will be performed free of charge and will take approximately 2.5 hours to complete.

ACTIONS YOU SHOULD TAKE

Navistar's records indicate that you own a vehicle involved in this recall. The vehicle is identified on the enclosed card.

If you own this vehicle, please schedule an appointment with any INTERNATIONAL® dealer to have your vehicle repaired. You can find your nearest dealer by calling 1-800-448-7825 or by using the dealer locator at <http://www.internationaltrucks.com>.

If you have already paid for repairs that corrected the defect, you may be eligible for reimbursement of certain repair expenses. Present your original repair paperwork and proof of payment to any INTERNATIONAL® dealer and your eligibility will be reviewed. You may also submit a claim using the enclosed Request for Reimbursement card.

If you are the lessor of this vehicle, please forward a copy of this notice to the lessee within ten days to comply with federal regulations.

If you do not own this vehicle, please fill out and return mail the enclosed card so that you will not be contacted again about this recall.

IF YOU NEED FURTHER ASSISTANCE

If you believe that Navistar has failed to remedy the defect without charge or within a reasonable time, please follow the procedure described in the Owner Assistance Guide section in your Owner's Manual or call toll free 1-800-448-7825.
