Triple E Recreational Vehicles has decided that certain 2012 & 2013 Libero, Serenity, Unity's & Regency GT's motorhomes manufactured between November 30/2011 and April 17/2013 fail to conform to Federal Motor Vehicle Safety Standard No. 108, "Lamps, Reflective Devices, and Associated Equipment.

Description of the Noncompliance:

The rear license plate light does not meet with DOT regulations when one light is used, as supplier requirements state. The license plate light currently installed has a frosted lens. Thus, making the license plate not clearly visible in the dark.

To Have This Modification Performed:
