Models Affected: 2012 Ford F350-550 Super Duty Cab Chassis with (DRW), Gas Engine / Service Body Application.

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Issue:

Manning Equipment, LLC has decided those units up-fitted with Service Bodies on Ford Super Duty chassis with dual rear wheels and gas engine and were built October 10, 2011 through June 29, 2012 will require an exhaust extension to redirect the exhaust spray down and away from the service body compartment floor. The exhaust spray on some of these vehicles was discoloring paint and/or primer in the lower floor area and damaging the plastic drain plugs in compartment floor above the exhaust. In one instance a fire was reported due to the improper storage of flammable material in the compartment above the exhaust.

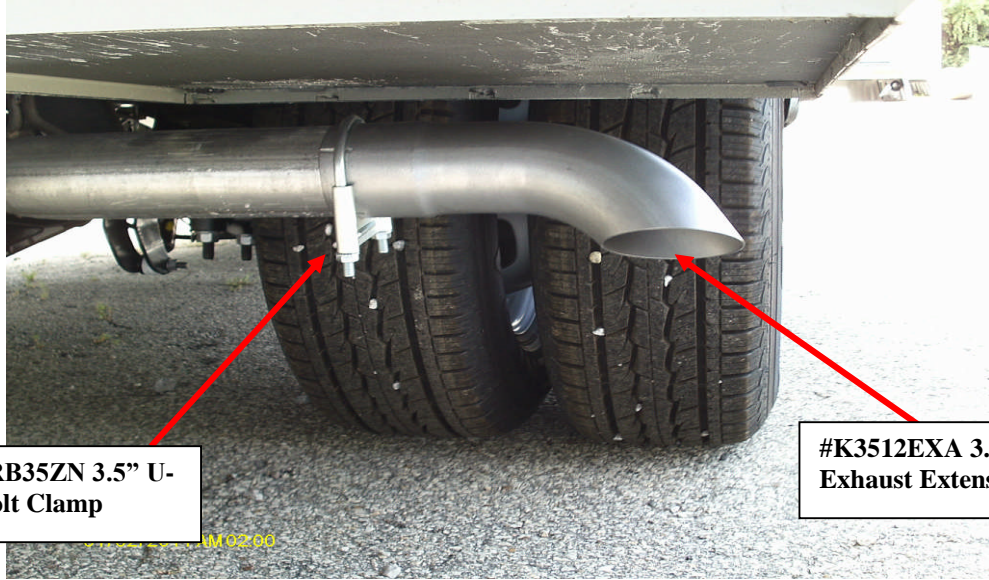
Action:

Manning Equipment has identified the above unit that was shipped to your facility and should apply to this Service Advisory for exhaust spray at right rear compartment. Manning Equipment will furnish at no charge an Exhaust Extension, U-bolt clamp, Warning Decal, and Drain Plugs for your unit. Please call, fax, or email me at below and confirm that this unit is still at your facility. I will require a ship to address, POC (Point of contact), and a phone number. After I receive this information Manning will ship the above components for installation on your vehicle to your specified location. If for some reason you are not able to install these components you may take your truck to the closest Truck Center in your area to have these components installed. Manning will pay up to (1) hour labor for this repair, please have the Truck Center phone me for direct payment.

We apologize for any inconvenience this may cause and thank you in advance for your cooperation in this matter.

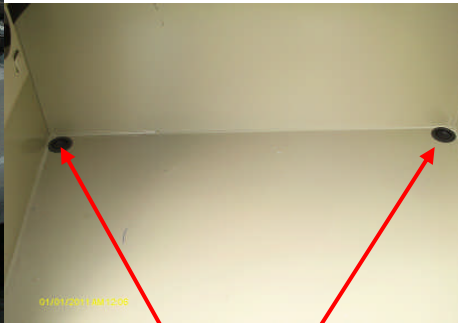

Note: If body is up fitted with two compartments at the rear, decal must be installed in the compartment closest to the truck exhaust pipe.
