## IMPORTANT SAFETY RECALL

Recall Campaign No. 13V-407: Rear Lamp Bulb Carrier

Dear BMW Owner/Lessee:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

BMW AG has decided that a defect, which relates to motor vehicle safety, exists in certain Model Year 2008-2010 5 Series (including M5) Sedans. Our records indicate that you are the owner of a potentially affected vehicle.

### IMPORTANT NOTICE

Please note that we had informed you of this matter by letter in November, and indicated that the necessary parts for your vehicle were not yet available. In our November letter, we stated that we would inform you when parts were available, and to schedule a visit with your authorized BMW center at that time. With this letter, we are pleased to inform you that the necessary parts are now available, and we encourage you to schedule an appointment with your authorized BMW center as soon as possible.

### DESCRIPTION OF PROBLEM

This Recall involves the bulb carrier ("bulb holder") within the rear lamp. Within the bulb carrier, the electrical contacts may be susceptible to corrosion due to aging and environmental influences. As a result, this corrosion of the contacts could render the rear lamp inoperative. Although the non-affected rear lamp and the center high-mounted stop lamp ("third brake lamp") provide redundant lamp functions to the driver of a vehicle behind you, if that driver does not notice illumination of these lamps, this could increase the risk of a crash.

### DESCRIPTION OF REPAIR

The left and right-side rear lamp bulb carrier will be replaced by a new version.

The actual repair will require approximately one hour; however, additional time may be required, depending on the BMW center's schedule. This work will be performed *free of charge* by your authorized BMW center.

### PRECAUTIONS FOR YOUR SAFETY

1. CONTACT YOUR AUTHORIZED BMW CENTER IMMEDIATELY TO HAVE THE NECESSARY REPAIR PERFORMED AS SOON AS POSSIBLE.

2. If the vehicle is experiencing this condition, you may continue to drive your vehicle, but drive cautiously and carefully, as the driver of a vehicle behind you may not notice a bulb outage.
3. If this issue were to occur, the non-affected rear lamp and the center high-mounted stop lamp ("third brake lamp") would provide redundant lamp functions to the driver of a vehicle behind you.
4. If the vehicle is experiencing this condition, a number of visual and audible warnings are provided. A warning symbol will appear in the vehicle's "message center" in the instrument panel. If the condition involves the turn signal, the turn signal symbol in the instrument panel flashes (and sounds) at twice its normal frequency. In addition, each time the vehicle is started, an audible signal is made.
5. If you are not the only driver of this vehicle, please advise all other drivers and passengers of this important information.

If you are no longer the owner of this vehicle, we would appreciate your furnishing us with the name and address of the new owner, using the enclosed postage-paid card.

If you are a lessor of this vehicle, Federal Regulations require you to forward this notice to your lessee with ten days.

If you have already had this repair performed at your own expense, please see the attachment regarding possible eligibility for reimbursement.

We sincerely apologize for any inconvenience this may cause you. TREAD ACT CUSTOMER REIMBURSEMENT PLAN

If you have paid for the repair described in the attached letter, and you would like to be considered for reimbursement, please contact your authorized BMW center. Expenses from repair facilities outside of the BMW center network will be considered; however, the procedure must meet BMW standards.

Your authorized BMW center will request a copy of your owner notification letter, as well as, a copy of your previously paid invoice, and then inspect the vehicle (if it is still in your possession) prior to submitting a claim on your behalf to BMW of North America, LLC for reimbursement.

Please note the following:

- Only a repair that is the subject of this safety recall is reimbursable. Consequential expenses such as towing, rental, accommodations, damage repairs, etc will not be reimbursed.
- The Manufacturer's Suggested Retail Price (MSRP) for BMW Genuine Parts will be considered as the guideline for reasonable charges.
- Expenses for repairs performed more than 10 days after the date of the last owner notification letter sent by BMW are not eligible for reimbursement.
- Taxes and hazardous waste disposal, where previously paid, are eligible for reimbursement.

We anticipate that your authorized BMW center will be able to answer any questions that you may have regarding your qualifications for reimbursement of a previous repair. If you qualify for such a reimbursement, they will also be able to advise you of the manner in which you could receive reimbursement.

We recommend that your authorized BMW center be your primary contact on this issue; however, our Customer Relations and Services Department may be contacted at 1-800-831-1117 for any special assistance that you may require.
