Recall Campaign No. 13V-454: Vacuum Pump Oil Supply

Dear BMW Owner/Lessee:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

BMW AG has decided that a defect, which relates to motor vehicle safety, exists in certain model year 2012-14 BMW 3 Series Sedans, 3 Series Sports Wagons, 5 Series Sedans, X1 SAV, X3 SAV and Z4 models. Our records indicate that you are the owner of a potentially affected vehicle.

IMPORTANT NOTICE

Please note that we had informed you of this matter by letter in November, and indicated that the necessary parts for your vehicle were not yet available. In our November letter, we stated that we would inform you when parts were available, and to schedule a visit with your authorized BMW center at that time. With this letter, we are pleased to inform you that the necessary parts are now available, and we encourage you to schedule an appointment with your authorized BMW center as soon as possible.

DESCRIPTION OF PROBLEM

This Recall involves the power assist braking system. In rare cases, the power assist braking system may not function properly. A loss of power assist braking would require you to provide greater brake pedal force. Although hydraulic braking (braking without power assist) remains available, a longer distance would be needed to stop the vehicle, possibly increasing the risk of a crash.

DESCRIPTION OF REPAIR

The power assist braking system will be inspected and, if necessary, the sealing cap will be secured, which will ensure the brake vacuum pump is lubricated properly.

The actual repair will require approximately two hours; however, additional time may be required depending on the BMW center's schedule. This work will be performed free of charge by your authorized BMW center.

PRECAUTIONS FOR YOUR SAFETY

1. CONTACT YOUR AUTHORIZED BMW CENTER IMMEDIATELY TO HAVE THE NECESSARY REPAIR PERFORMED AS SOON AS POSSIBLE.

2. If you notice a loss of power assist braking (greater pedal pressure is required), the vehicle may be experiencing this condition.
3. If this condition occurs, hydraulic braking (braking without power assist) remains available, although a longer distance would be needed to stop the vehicle.
4. IF YOU NOTICE A DECREASE OF POWER BRAKE ASSIST, DO NOT CONTINUE TO DRIVE YOUR VEHICLE. Carefully move away from traffic and pull over to a safe location as soon as possible. Contact BMW Roadside Assistance at 1-800-332-4269 to have your vehicle brought to the nearest authorized BMW center.
5. If you are not the only driver of this vehicle, please advise all other drivers and passengers of this important information.

If you are no longer the owner of this vehicle, we would appreciate your furnishing us with the name and address of the new owner, using the enclosed postage-paid card.

If you are a lessor of this vehicle, Federal Regulations require you to forward this notice to your lessee within ten days.

If you have already had this repair performed at your own expense, please see the attachment regarding possible eligibility for reimbursement.

We sincerely apologize for any inconvenience this may cause you. We appreciate your confidence in our product, and we wish to do everything we can to retain it. If you have paid for the repair described in the attached letter, and you would like to be considered for reimbursement, please contact your authorized BMW center. Expenses from repair facilities outside of the BMW center network will be considered; however, the procedure must meet BMW standards.

Your authorized BMW center will request a copy of your owner notification letter, as well as, a copy of your previously paid invoice, and then inspect the vehicle (if it is still in your possession) prior to submitting a claim on your behalf to BMW of North America, LLC for reimbursement.

Please note the following:

- Only a repair that is the subject of this safety recall is reimbursable. Consequential expenses such as towing, rental, accommodations, damage repairs, etc will not be reimbursed.
- The Manufacturer's Suggested Retail Price (MSRP) for BMW Genuine Parts will be considered as the guideline for reasonable charges.
- Expenses for repairs performed more than 10 days after the date of the last owner notification letter sent by BMW are not eligible for reimbursement.
- Taxes and hazardous waste disposal, where previously paid, are eligible for reimbursement.

We anticipate that your authorized BMW center will be able to answer any questions that you may have regarding your qualifications for reimbursement of a previous repair. If you qualify for such a reimbursement, they will also be able to advise you of the manner in which you could receive reimbursement.
