Carbon Ceramic Brake Screws Replacement
Your Lamborghini «Model» with chassis number: «VIN»

Dear Sir/Madam,

This notice is sent to you in accordance with the requirements of the National Traffic Motor Vehicle Safety Act".

In the course of continuous product monitoring and internal tests, Automobili Lamborghini S.p.A. has decided that the stainless steel screws securing may fail due to stress corrosion cracking if the vehicle has been used in salt environments. This may lead to an increase in stopping distance and could lead to a crash.

Your vehicle is one of the models affected.

Please contact an authorized Lamborghini Dealer or Service Point without delay to arrange an appointment. Please bring this letter and your Service Booklet with you when you visit the dealer, so that we can make all necessary entries.

We will replace the disc fasteners free of charge in the estimated time of 3 working hours. The visit may require you to leave your car at least 1 business day at the workshop.

Any Lessor that receives this notification must send a copy of this notice to the Lessee within 10 days.

Lamborghini will reimburse an owner who has already incurred costs to obtain a remedy for the problem addressed by this recall by reimbursing for all customer pay brake disks and screws (other than caused by accident or abuse) done on affected vehicles prior to the recall. Contact your Lamborghini dealer for the reimbursement presenting the invoice of disks and screws.
