RE: RECALL CAMPAIGN –REAR CARBON CERAMIC BRAKES – REPLACEMENT OF SCREWS

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. Bentley Motors has decided that a defect, which relates to motor vehicle safety, exists in certain 2007-2011 model year Bentley vehicles fitted with carbon ceramic brakes. Our records show that you are the owner of one of these vehicles.

What is the issue?

On the rear carbon ceramic brakes (CSiC), the stainless steel screws fixing the rotor to the metal bell may fail. If 8 of the 10 screws were to fail there would be an increase in the vehicle's stopping distance and this could lead to a crash.

What will we do?

To help correct this defect, your authorized Bentley dealer will replace the existing stainless steel screws on your rear carbon ceramic brakes with new titanium screws. This work will take about three hours to complete and will be performed for you free of charge. Please keep in mind that your dealer may need additional time for the preparation of the repair, as well as to accommodate their daily workshop schedule.

What should you do?

Please telephone your authorized Bentley dealer without delay to schedule a repair appointment. Your dealer has all the necessary parts and instructions to perform the repair to your satisfaction.

Lease vehicles

If you are the lessor and registered owner of the vehicle identified in this action, the law requires you to forward this letter immediately via first-class mail to the lessee within ten (10) days of receipt.

Can we assist you further?

We would like you to know that we sincerely appreciate your continued support of our cars. I do apologize for the fact that we have to ask you to allow us to recall your car for this modification.
