IMPORTANT SAFETY RECALL**N63 / NHTSA 13V-527**

This interim notice applies to your vehicle (VIN: xxxxxxxxxxxxxxxxxxxx).

This interim notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Chrysler has decided that a defect, which relates to motor vehicle safety, exists in some **2008 through 2012 model year RAM 4500/5500 series Trucks**.

The problem is... The left tie rod ball stud on your truck may fracture under certain driving conditions. This could cause a loss of directional control and/or crash without warning.

What your dealer will do... Chrysler intends to repair your vehicle free of charge (parts and labor). However, the parts required to provide a permanent remedy for this condition are currently not available. Chrysler is making every effort to obtain these parts as quickly as possible. Chrysler will contact you again by mail, with a follow-up recall notice, when the remedy parts are available. In the meantime, Chrysler recommends that you make an appointment after February 10, 2014 for an inspection of your steering linkage. If your left tie rod ball stud is misaligned, Chrysler will install a new tie rod and perform a front end alignment on your vehicle. If your left tie rod ball stud is aligned properly, no further action is required until you receive the follow-up notification.

What you must do to ensure your safety... Simply contact your Chrysler, Jeep, or Dodge dealer after February 10, 2014 to schedule a service appointment to have your steering linkage inspected. If your left tie rod ball stud is misaligned, Chrysler will install a new tie rod and perform a front end alignment on your vehicle. If the left tie rod ball stud is aligned properly, you will be instructed to schedule another service appointment when the new steering linkage parts are available. **Please bring this letter with you to your dealer.**

If you have already experienced this condition and have paid to have it repaired, please send your original receipts and/or other adequate proof of payment to the following address for reimbursement: Chrysler Customer Assistance, P.O. Box 21-8007, Auburn Hills, MI 48321-8007, Attention: Reimbursement. Once we receive and verify the required documents, reimbursement will be sent to you within 60 days.
