Customer Verbiage

"FCA US and NHTSA have signed a consent agreement which includes the requirement to offer a buyback of certain eligible vehicles that are included in recalls N08, N49 and R16. This will only include vehicles that have not yet been repaired under these recalls."

"Vehicles that have already been repaired under N08, N49 and R16 are not eligible for repurchase."

"If you have already had your vehicle repaired, no action is required at this time."

"Customers who have not had their vehicles remedied will have the option of having the recall repair performed or having their vehicle repurchased. This offer will be extended to current owners, regardless of position of ownership (including second owner, third owner, etc.). The offer will not include any allowance for modifications or upgrades made to the vehicle, i.e. tow bed, lift/winch kit, etc.)."

"The details of the repurchase of these vehicles will be defined in the coming weeks, and all customers whose vehicles are included in these populations will be contacted, by mail in the next 60 days."

Note: Details regarding process and/or mechanism for handling repurchase are currently being finalized. Affected owners who have NOT had N08, N49 and R16 repairs completed will be contacted in the next 60 days with details.

Note: Where possible, please attempt to minimize dealer and/or customer referral contact with the Customer Assistance Center regarding N08, N49, and R16 inquiries.
