Recall Number 13S10 - Exhaust Gas Temperature Sensor Replacement

What is the Issue?

On your vehicle, it may be possible for an exhaust temperature sensor to fail, and cause the vehicle to go into shutdown mode. If this occurs, the warning "Stop Safely Now" will display in the message center followed by five chimes; engine power will reduce progressively until the vehicle speed is under four miles per hour and then the engine will shut off. The engine will be prevented from restart for at least one hour. If this were to occur when the ambulance is transporting a patient, it may delay medical treatment and increase the risk of injury to the patient.
