Ford Motor Company previously sent to you a letter indicating that a defect which relates to motor vehicle safety exists in your vehicle, with the Vehicle Identification Number shown above.

We apologize for this situation and the delay in part availability and want to assure you that, with your assistance, we will correct this condition. Our commitment, together with your dealer, is to provide you with the highest level of service and support.

What is the issue?	On your vehicle, localized overheating of the engine cylinder head may cause the cylinder head to crack, causing an oil leak that may result in a fire in the engine compartment (NHTSA Recall 13V-583).
What will Ford and your dealer do?	Ford Motor Company has authorized your dealer to make repairs to address potential overheating that may result in a fire in the engine compartment. Additionally, some vehicles have been observed with an engine oil overfill condition that occurred when the oil capacity was not properly identified during service. A revised dip stick and label will be added to help with proper maintenance. These enhancements and repairs will be completed free of charge (parts and labor).
How long will it take?	The time needed for this repair is less than one day. However, due to service scheduling requirements, your dealer may need your vehicle for a longer period of time.

What should you do? Please call your dealer without delay and request a service date for Recall

13S12. Provide the dealer with the Vehicle Identification Number (VIN) of your vehicle. The VIN is printed near your name at the beginning of this letter. If you do not already have a servicing dealer, you can access www.Fordowner.com for dealer addresses, maps, and driving instructions. Please note: Federal law requires that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within ten days.
