**What is the Issue?** Your vehicle may not conform to the requirements specified by Federal Motor Vehicle Safety Standard (FMVSS) No. 114, Section 5.3, Theft Protection and Rollaway Prevention. Your vehicle may have been built with a transmission range sensor that does not function properly and allows the transmission to shift out of Park without the brake pedal applied, increasing the risk of unintended vehicle movement.
