Potential Number of Units Affected: 84

Problem Description:

Jet Company, Inc. (Jet Company) is recalling certain model year 2014 Side Dump Trailers manufactured January 8, 2014, to March 6, 2014, and equipped with certain SAF-Holland-brand CBX Trailer Suspension Air Ride Axle Systems. The affected trailer suspensions have pivot bolts that may fail.

Consequence:

Failure of the pivot bolts may cause the suspension and attached axle to separate from the trailer, increasing the risk of a crash.

Remedy:

Jet Company will notify owners, and dealers will replace the pivot bolts, free of charge. The recall is expected to begin in mid-October 2014. Owners may contact Jet Company customer service at 1-515-332-3117.

We have received Jet Company's proposed owner notification letter and it is currently under review. You will be notified of any changes or concerns once our review is complete.

Please be reminded of the following requirements:

Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
