Identification of Vehicles

The vehicle models involved in this recall are:

2013-**2014** model year Bay Star Sport; Bay Star; Canyon Star; Ventana LE; Ventana; Dutch Star; Mountain Aire and Essex Class A motor homes.

These vehicles were manufactured by Newmar Corporation between 2/18/2013 and 11/15/2013.

Comprehensive Vehicle Population

The total number of vehicles included in this campaign is **634**.

Effected Population Assessment

100% of the vehicles identified above may contain defective equipment.

Defect Description

Frigidaire microwave KG series, have a possibility to start up on its own. The keypad is defective and not the circuit board as previous stated by Frigidaire. When the door is closed the microwave will go on for up to three minutes and then shut off. It will not turn on again unless the door is reopened and closed again. If microwave starts on its own and contents are inside a fire could result.

Certain recreational vehicles manufactured by Newmar Corporation, as Identified above, which were equipped by **Newmar** Corporation with **Frigidaire KG series microwaves** that have been identified by **Frigidaire** Corporation as potentially hazardous. **Newmar** Corporation is filling a recall serving notice of their intent to recall these **Frigidaire KG series microwaves**.

Principle Event Chronology

Newmar Corporation is reporting this recall following notification, by a representative of **Frigidaire** Corporation, of a potential defect. Several customers reported incidents of these microwaves starting on their own. Following meeting with representatives at Frigidaire and subsequent investigation, Newmar has decide to file a recall.

Newmar Corporation is not aware of any property damage, injury, or death, in vehicles manufactured by Newmar Corporation, attributed directly or indirectly to this defect.
